1. Information We Collect

We may collect various types of personal information, including but not limited to:

3. Data Sharing and Disclosure

We may share your personal information with third parties in the following cases:

- 3.1. Service Providers: We may engage third-party service providers who assist us in operating our business or provide services on our behalf. These providers have access to your personal information only to perform specific tasks and are obligated to keep it confidential.
- 3.2. Legal Requirements: We may disclose your personal information if required to do so by law or in response to valid legal requests, such as subpoenas or court orders.
- 3.3. Business Transfers: In the event of a merger, acquisition, or sale of all or a portion of our assets, your personal information may be transferred to the acquiring entity.

4. Data Security

We employ industry-standard security measures to protect your personal information from unauthorized access, disclosure, alteration, or destruction. However, please note that no method of transmission over the internet or electronic storage is 100% secure.

5. Your Rights

- 5.4. Withdrawal of Consent: You can withdraw your consent for the processing of your personal information, where consent is the legal basis for processing.


